Subject: Second Notice of the Tenth Annual Meeting of the AzISA Members and Regular Meeting of the AzISA Board of Directors

The 10th Arizona Independent Scheduling Administrator Association's (AzISA) Annual Members' meeting and the regular meeting of the Board of Directors will be held Tuesday, September 9, 2008 beginning at 1:30pm Arizona time in the Phoenix office building of Low & Childers at 2999 N. 44th St, 6th floor conference room, Phoenix, Arizona 85018, as previously noticed in prior e-mail communications sent on or about August 3, 2008. A map is attached with "A" depicting the location.

This notice is also being sent using e-mail to member representatives and alternate member representatives, as well as interested parties to encourage attendance and participation so that a quorum of Members is present and so that action items can be considered and acted upon. We need two more Classes with five members, of which three Members need to be present or call -in to constitute a quorum. New Board of Directors with terms expiring in 2008 (see attached list) will be elected. It is important to elect them so that we can conduct Board business of considering proxy voting, approving the 2009 budget and setting the Executive Director's priorities for 2009. Updates of transmission activities in Arizona and the West will also be provided during this meeting. A call-in line will be available, but your attendance at the Annual Meeting is encouraged.

TENTH ANNUAL MEETING OF THE MEMBERS OF THE ARIZONA ISA (AZISA) ACTION ITEMS

Election: The primary purpose of the Annual Meeting of the Members is to elect Member Class Chairs, the overall Members Chair, and to elect two class representatives to the Board of Directors of the AzISA. Certain Directors terms have expired. In accordance with the AzISA By-Laws, Section 4.4.1, "Election Process: Each Member Class shall be represented by two Board members. At the second special meeting and at each annual meeting, voting Members for each Member Class shall elect candidates for Board positions to be filled by that Member Class."

As a reminder, in order to be eligible to vote in any election or on any issue that comes before the Members or to participate in any activities of AzISA, a Member must be current in the payment of its dues. An Invoice will be provided next week by email and will be available at the Annual Meeting for the \$250 annual membership dues and you may bring a check with you to the Annual Meeting to be current for dues payment in 2008 and to meet the voting requirements.

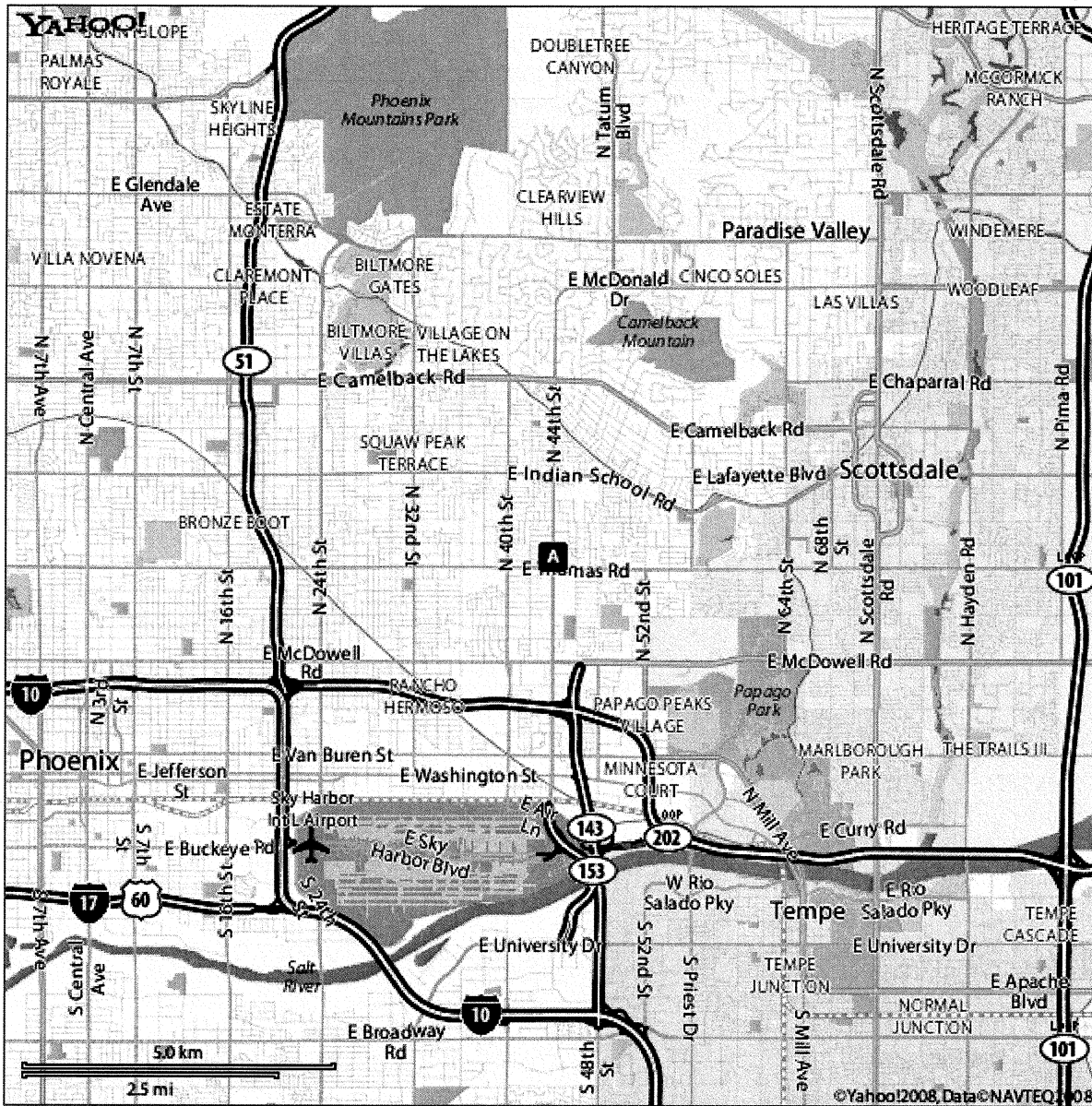
