# **Arizona Independent Scheduling Administrator Association**

Minutes from the Ninth Annual Members Meeting Tuesday, September 11, 2007 at 1:30 PM

#### I. Call to Order

Ed Beck, Members Chair, called the Ninth Annual Members Meeting of the Arizona Independent Scheduling Administrator Association ("AZ ISA") to order at approximately 1:30 PM.

#### **VIII.** Articles of Incorporation

Patrick Sanderson led a discussion regarding the section of the Articles of Incorporation which sets the date of termination of the corporation in 2008. Mr. Sanderson recommended to the Members that the corporation be renewed for another five (5) years.

#### IX. Financial Condition

Mr. Sanderson discussed the AISA financial condition with the Members. A review of the "Year In Review" section showed that the corporation's actual financial results were better than its budget by \$7,000. This is not entirely accurate because of the Bank's mishandling of the D&O insurance premium payments. Mr. Sanderson used this opportunity to let the Members know that AISA does have D&O and E&O coverage.

Ms. Chamberlin raised the possibility of increasing the \$5,000,000 limits on D&O and E&O insurance if the level of retail transactions increases in Arizona in the upcoming years.

Mr. Chen asked for an explanation of D&O and E&O insurance. Ms. Sanderson explained that Directors & Officers coverage limits are \$5,000,000 each and that Errors & Omissions coverage limits are also \$5,000,000 each.

### X. 2008 Budget

Mr. Sanderson then reviewed and discussed a draft of the 2008 Budget with the Members.

Ms. Chamberlin questioned the office budget. Mr. Sanderson said that a new printer would be required.

Mr. Chen raised the issue of why the 2007 travel budget item was less than the actual amount. Mr. Sanderson advised that he had not been required to incur as many travel activities. Also, he tried to use internet tools to minimize his travel.

Mr. Beck suggested that specifics of the budget be deferred to and discussed at the Board Meeting.

#### **XI.** Notice of Next Annual Members Meeting

The next Members meeting will be held on September 9, 2008.
